The Tenderer described below (“**Tenderer**”) hereby offers to lease from the Agri-Food & Veterinary Authority of Singapore (“**Lessor**”) Land Parcel(s) from the list of Land Parcels described above for a term of **twenty (20) years** from a date to be determined by the Lessor subject to the Conditions of Tender and the Technical Conditions of Tender issued by the Lessor in the Invitation to Fixed Price Tender for the above Land Parcels and also on the terms and conditions set out in the Building Agreement appended to the Conditions of Tender at **Appendix B** and the Form of Lease appended to the Conditions of Tender at **Appendix C** and at the Fixed Sale Price indicated in the Price Schedule attached hereto. **Only a maximum of 3 Land Parcels are allowed.**

The Tenderer is to mark with a tick in the box for only those Land Parcel(s) that he wants to tender for. It is mandatory for the Tenderer to indicate the Land Parcel(s) that he wants to tender for as the 1st Selection. It is optional for the Tenderer to indicate as Alternative Selections other Land Parcel(s) that are acceptable to him. The number of Land Parcel(s) indicated for each Alternate Selection must be the same as the number of Land Parcel(s) indicated as the 1st Selection.

In the event that a Tenderer is not awarded the Land Parcel(s) indicated as the 1st Selection, the tender evaluation committee will consider the Tenderer's selections in his Alternative Selections and determine if the Tenderer ought to be awarded the Land Parcel(s) based on the Tenderer's Alternative Selections. The tender evaluation committee shall not be bound to consider the Land Parcel(s) in order of preference if the Tenderer has indicated Alternative Selections of Land Parcel(s). Please note that the Tenderer should NOT repeat his choice across different selections, e.g. if the Tenderer selects LCK 176A, LCK 176B and LCK 176C for the 1st Selection, he must not select the same three Land Parcels as any of his Alternative Selections.

AVA reserves the right not to award the tender to any Tenderer for any of the Land Parcel(s) indicated as his 1st Selection or Alternative Selections without assigning any reason. If the Tenderer rejects the award of any Land Parcel(s) in accordance with any of the Tenderer's Selections, the Fixed Amount Tender Deposit submitted by the Tenderer shall be forfeited and AVA shall reserve all its rights and remedies under the Conditions of Tender.

3 Tender Proposal Form

4 Terms and Conditions

In the event of this Tender being accepted, the Tenderer agrees to:

- i. Comply with each and every of the terms and conditions set out or referred to in the Conditions of Tender;
- ii. Pay by cashier's order twenty-five percent (25%) (less the Fixed Amount Tender Deposit mentioned below) of the Fixed Sale Price together with the amounts of Goods and Services Tax ("**GST**") payable in relation to the payment of the said twenty-five percent (25%) of the Fixed Sale Price within twenty-eight (28) days of the date of acceptance of this Tender;
- iii. Pay by cashier's order the remaining seventy-five (75%) of the Fixed Sale Price, together with the GST payable in relation to such payment within ninety (90) days of the date of acceptance of this Tender;
- iv. Pay by cashier's order the sum listed in the table below in accordance to the number of Land Parcels awarded being the Cadastral Survey Cost on or before the date of expiry of the 90 Day Period;
