- C. The tender for the said parcels of land shall be based on a Concept & Price Tender System. Under this system, the Tender Proposals submitted by all tenderers will be first evaluated by a Concept Evaluation Committee ("CEC") appointed by AVA. Only tenders submitted by tenderers whose Tender Proposals have been shortlisted by the CEC can be considered for acceptance. In the second stage, a Tender Evaluation Committee evaluates the Tendered Sale Price of the shortlisted proposals. The Tenderer shall submit in his tender the Form of Tender (indicating the Tendered Sale Price) and the Tender Proposal Form, which shall be prepared in accordance with the requirements as set out in the Technical Conditions of Tender. Tenders shall be evaluated and assessed with respect to the Tender Proposal Form in accordance to the Tender Evaluation Criteria in Part V of the Technical Conditions of Tender.
- D. For the purpose of submitting a Tender, each Tenderer shall pay the tender deposit for the amount of <u>Singapore Dollars Twenty Thousand (\$\$20,000/-)</u> in accordance with the number of Land Parcels tendered ("Fixed Amount Tender Deposit"). The Fixed Amount Tender Deposit submitted by the Tenderer shall be exclusive of GST. The Successful Tenderer shall bear and pay to the Government (in addition to the Sale Price for the Land Parcels) all amounts of GST charged on the supply of goods and services.
- E. The Fixed Amount Tender Deposit shall be paid at the time of submission of Tender by way of cashier's order(s) drawn in Singapore currency made payable to "Agri-Food and Veterinary Authority of Singapore".
- F. The Tenderer shall complete and sign both the Tender Proposal Form and Form of Tender provided in the Tender Packet.
