HIGH PATHOGENICITY AVIAN INFLUENZA (H5N1) IN USA

USA reported outbreaks of H5 highly pathogenic avian influenza (HPAI) in poultry in the following regions listed below.

- i. Cache County, Utah
- ii. Knox County, Nebraska
- iii. Weld County, Colorado
- iv. Sequoyah County, Oklahoma

2 In view of the outbreaks, the National Parks Board/Animal & Veterinary Service (NParks/AVS) will impose a temporary restriction on the importation of ornamental birds, poultry and poultry products from the 10km radius restricted area around the affected premises with effect from the respective dates as stated below. Heat-treated poultry products which comply with the OIE guidelines for inactivation of AI virus will not be subjected to the restriction.

Cache County, Utah	25 April 2022
Knox County, Nebraska	27 April 2022
Weld County, Colorado	29 April 2022
Sequoyah County, Oklahoma	30 April 2022

3 Poultry consignments exported from the affected areas in the following regions, that meet the following slaughter and export dates will continue to be accepted for import.

Region(s)	Slaughter date	Export date
Cache County, Utah	Before 11 April 2022	Before 25 April 2022
Knox County, Nebraska	Before 13 April 2022	Before 27 April 2022
Weld County, Colorado	Before 15 April 2022	Before 29 April 2022
Sequoyah County, Oklahoma	Before 16 April 2022	Before 30 April 2022

4 In order to facilitate the clearance of permits for poultry and poultry products, we would require the following attestations to be included in the veterinary health certificate accompanying the import of poultry and poultry products:

- a) Highly pathogenic avian influenza (HPAI) is a notifiable disease in the United States.
- b) The birds from which the meat was sourced were not vaccinated against HPAI, as defined by the World Organisation for Animal Health (OIE).
- c) The poultry meat and meat products were not derived from poultry originating from areas within the 10 km radius restricted zone(s) established around a premise affected with HPAI in poultry as defined by the OIE.
- d) The birds from which the meat was derived were hatched, raised, and slaughtered in the United States, or were legally imported as day-old chicks from countries with equivalent poultry health status.
