HIGHLY PATHOGENIC AVIAN INFLUENZA (HPAI) IN GERMANY

Germany reported outbreaks of highly pathogenic avian influenza (HPAI) in poultry in the following regions listed below.

- i. Lewitzrand, Parchimer Umland, Ludwigslust-Parchim, Mecklenburg-Vorpommern (23-015-01199)
- ii. Selk, Haddeby, Schleswig-Flensburg, Schleswig-Holstein (23-015-01201)
- iii. Barßel, Cloppenburg, Niedersachsen (23-015-01204)
- iv. Zernitz-Lohm, Neustadt (Dosse), Ostprignitz-Ruppin, Brandenburg (23-015-01213)
- v. Wurster Nordseeküste, Cuxhaven, Niedersachsen (23-015-01212)
- vi. Lorup, Werlte, Emsland, Niedersachsen (23-015-01215)

2 In view of the outbreaks, the National Parks Board/Animal & Veterinary Service (NParks/AVS) has imposed a temporary restriction on the importation of ornamental birds, poultry and poultry products from the 10km surveillance zone around the affected premises in the regions with effect from the respective dates as stated below. Heat-treated poultry products which comply with WOAH guidelines for inactivation of AI virus will not be subjected to the restriction.

4 In order to facilitate the clearance of permits for poultry and poultry products, we would require the following attestations to be included in the veterinary health certificate accompanying the import of poultry and poultry products:

(a) Highly pathogenic avian influenza (HPAI) is a notifiable disease in Germany.

(b) The birds from which the meat was sourced were not vaccinated against avian influenza (AI).

(c) The poultry meat and meat products were not derived from birds originating from (an) establishment(s) situated in a 10 km radius surveillance zone around a highly pathogenic avian influenza affected farm.

(d) The poultry from which the meat was derived were born, raised, and slaughtered in Germany, or were legally imported as day old chicks from countries with equivalent poultry health status.
