## 1. Licence Renewal

### Notification of Licence Renewal

**Step 0**

You will be reminded via email or letter to renew your licence at these stages before licence expiry:

1. 66 days before
2. 30 days before
3. 14 days before

The later reminders will not be sent if you had already renewed the licence.

**To note** You will need to submit a change in layout application in the following scenarios:

- Changing business concept from food stall to a mini restaurant
- Extending current food shop operations to include an additional unit (ie adjacent unit, upper level, etc) for preparation or dining area
- Making structural changes to the premises (eg: kitchen expansion, new exhaust system installation, new preparation area, etc)

**NOTE:** The scenarios above are not exhaustive. In addition, if the layout changes involve a food stall, the **main food shop operator** must submit the change in layout application.

Please follow the steps above and attach the following documents for processing

- Official letter indicating the changes (to include proposed changes and existing premises licence number)
- New proposed layout plan drawn to scale in metrics

When updating the business operating address, please add a placeholder unit number i.e., #00-00 for GoBusiness to accept the application. SFA will verify the unit number later.

The officer in charge will assess the application and contact you on the next course of action. Please **do not** start any renovation works nor sign any tenancy agreement with the landlord until SFA issues you the in-principal approval.

### 3. Licence Cancellation

If the business is no longer operating and the licence has not expired, please cancel your licence. If the licence has expired and the business has ceased, no further action required.

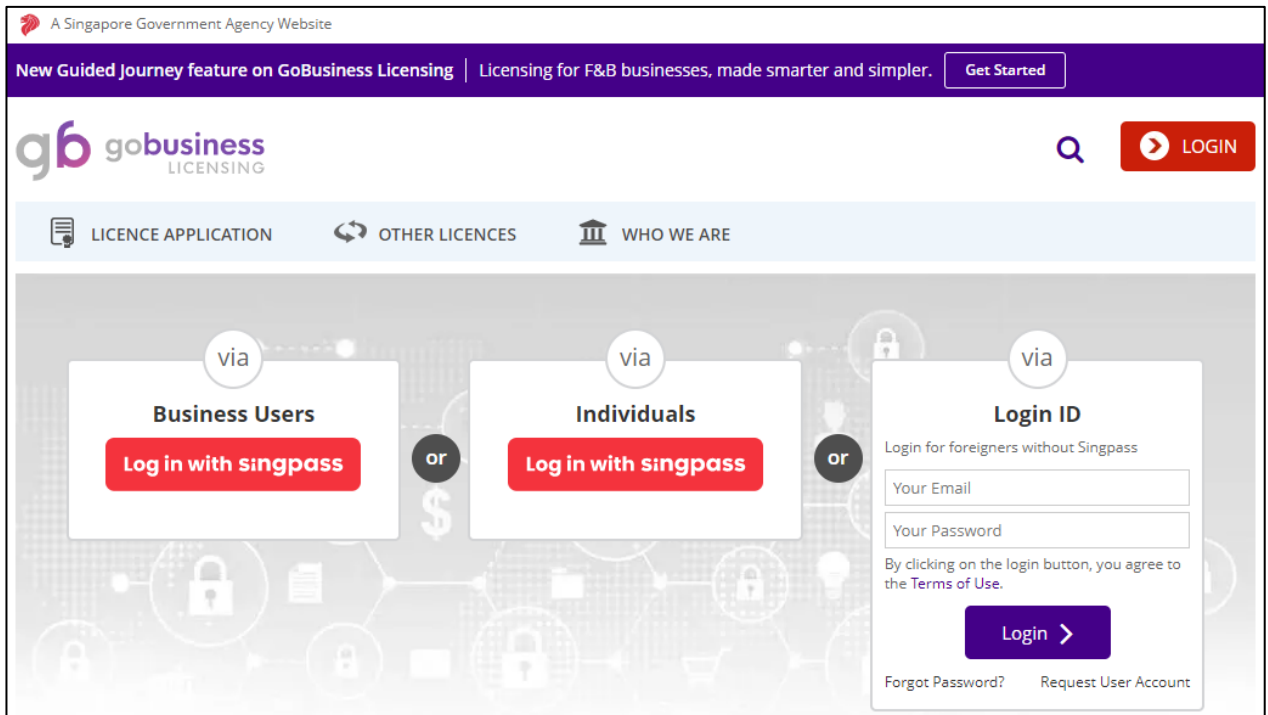




