

**TENDER CLOSING FOR 10 LAND PARCELS FOR FOOD FARMING
AT LIM CHU KANG**

The Singapore Food Agency (SFA) has closed the tender for 10 land parcels for food farming at Lim Chu Kang today.

2. The land parcels were launched for public tender on 19 June 2019. The land parcels were offered for sale on a 20-year lease term.

3. SFA received 3 proposals for beansprout farming, 6 proposals for General Agriculture (Food) farming, and 4 proposals for vegetable farming. Details of the bids received can be found in **Annex 1**.

4. To achieve our “30-by-30” vision to meet 30 per cent of our nutritional needs locally by 2030, our farms have to make efficient use of scarce resources such as land, water and energy. Farms should leverage technology to increase productivity and be sustainable and resilient against climate change. Proposals that can achieve high production levels sustainably will have a higher chance of being awarded these new land parcels. Proposals will be assessed on their production capability, track record, relevant experience and qualifications as well as innovation and business sustainability including waste management.

5. This release is not an announcement of tender award. A decision on the award of the tender will be made after the tender proposals have been evaluated. This will be announced at a later date.
