

**TENDER CLOSING FOR 2 LAND PARCELS FOR FOOD FARMING
AT LIM CHU KANG AND SUNGEI TENGAH**

The Singapore Food Agency (SFA) has closed the tender for 2 land parcels for food farming at Lim Chu Kang and Sungei Tengah today.

2 The land parcels were launched for public tender on 15 Sep 2020. The land parcels were offered for sale on a 20-year lease term.

3 SFA received 7 proposals for general agriculture (food) farming and 15 proposals for vegetable farming. Details of the bids received can be found in **Annex 1**.

4 To achieve our “30-by-30” goal to meet 30 per cent of our nutritional needs locally by 2030, our farms have to make efficient use of scarce resources such as land, water and energy. Farms should leverage technology to increase productivity and be sustainable and resilient against climate change. Proposals will be assessed on their production capability, track record, relevant experience and qualifications as well as innovation and business sustainability including waste management.

5 This release is not an announcement of tender award. A decision on the award of the tender will be made after the tender proposals have been evaluated and will be announced at a later date.
