CIRCULAR

LIST OF APPROVED FISH SUPPLIERS FOR SUPPLY OF SALMON FILLETS AND/OR READY-TO-EAT FISH SLICES

- 1. Following the joint press release by the Ministry of Health (MOH), National Environment Agency (NEA) and the Agri-Food & Veterinary Authority of Singapore (AVA) on 5 December 2015, all retail food establishments that wish to sell ready-to-eat (RTE) raw fish dishes, such as *yusheng* dishes, are to use only saltwater fish intended for raw consumption. Such fish are typically bred or harvested from cleaner waters, and stored and distributed according to appropriate cold chain management practices.
- 2. Food stalls (hawker centres, coffeeshops, canteens, food courts) and food establishments providing catering services that wish to purchase fish intended for raw consumption may refer to Annexes A, B and C for the list of establishments and importers which have been assessed to be suitable to supply fish for raw RTE use. The lists are subjected to updates and changes.
- 3. All the approved suppliers have been reminded to maintain proper hygiene, cold chain management, and good manufacturing practices when handling fish which are intended for raw consumption.
