- 4. The following is required if the Lessee or Tenant is an Individual, or Joint-Lessee/Tenant or Business Firm:
  - a. Copies of the NRIC(s) [front and back] of the Lessee/Tenant, Joint-Lessee/Tenant or sole-proprietor or all the partners in the Business Firm; and
  - Latest Medisave Contribution Payment Receipt(s) of the Lessee/Tenant, Joint-Lessee/Tenant or sole-proprietor or partners of the Business Firm.
