

<u>Update on 9 May 2020:</u> SFA has extended the recall to include the products below, as sulphur dioxide has been similarly detected in samples of these products at levels exceeding the maximum limit for sulphur dioxide as stated in the Singapore Food Regulations. We have directed four importers to recall the products and the recall is ongoing. Consumers can contact the importers for enquiries and for exchange or refund of the products. ### Recall of "Xiong Mao Pai" and "Fei Long Pai" bamboo fungus

The Singapore Food Agency (SFA) has detected sulphur dioxide, an allergen, in samples of two brands of bamboo fungus at levels exceeding the maximum limit for sulphur dioxide as stated in the Singapore Food Regulations.

- 2 The two brands, "Xiong Mao Pai 熊猫牌" and "Fei Long Pai 飞龙牌", were imported from China by Guangdong Import & Export Pte Ltd and Teck Sang Pte Ltd respectively. SFA has directed both importers to recall the implicated products. The recall is ongoing.
- 3 Excessive levels of sulphite<sup>1</sup> in food could result in allergic reactions in individuals who are hypersensitive to sulphite. Symptoms include hives, itchiness, stomach ache, diarrhoea and vomiting. Consumers who have purchased the implicated products should not consume them. Consumers who feel unwell may wish to seek medical attention.
