

SFA LAUNCHES TENDER FOR 5 LAND PARCELS FOR VEGETABLE FARMING AT LIM CHU KANG AND SUNGEI TENGAH

The Singapore Food Agency (SFA) has launched 5 land parcels for vegetable (Leafy Vegetable/Fruited Vegetable/Mushrooms) farming at Lim Chu Kang and Sungei Tengah for sale by public tender today.

- 2. Six tranches of farmland for tender have been launched since 2017, with this latest tender being the seventh tranche. Proposals that can achieve sustainably high production levels will have a higher chance of being awarded these land parcels. Every proposal will be assessed on its merits, in term of production capability, track record, relevant farming experience and qualifications as well as innovation and business sustainability, which includes the exercising of best farming practices.
- 3. "Our "30 by 30" vision aims to build an agri-food industry with the capability and capacity to sustainably produce 30% of Singapore's nutritional needs by 2030. Given that less than 1% of land is set aside for agriculture food production, this can only be achieved if farms leverage on technology and innovation to increase productivity and be sustainable and resilient against climate change. Land tenders are tailored to support promising farms with feasible/concrete plans, while incorporating sustainability and circular design concepts. SFA will work with farms, including successful tenderers in the land tender exercises, to transform our agri-food industry and bolster Singapore's food security," said Ms Wong Sheau Fong, SFA's Senior Director, Food Infrastructure Development & Management Division.
- 4. Details of the land parcels and the location plans are in <u>Annex 1 and 2 respectively</u>. The tender for the land parcels will close at 12 noon on 7 December 2023 (Thursday).
